LXI SOFTWARE END USER LICENSE AGREEMENT

BEFORE YOU CLICK ON THE ACCEPT BUTTON RELATED TO THIS LICENSE, CAREFULLY READ ALL THE TERMS AND CONDITIONS OF THIS AGREEMENT. BY CLICKING ON THE “ACCEPT” BUTTON, YOU ARE CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CLICK THE “DECLINE” BUTTON AND DO NOT USE THIS LXI CONSORTIUM, INC. SOFTWARE.

This LXI Software End User License Agreement (the “Agreement”) is a legal agreement between you and LXI Consortium, Inc., a Delaware corporation (“LXI”) for the LXI Reference Design Software product. In this Agreement, the term “LXI Software” means the LXI Reference Design Software product that is provided by LXI, including without limitation computer software, source code, design files, build files, sample executables, associated media and printed materials, and online or electronic documentation. You are being provided with access to the LXI Software because the company by which you are employed is a member of LXI (the “Member”). The term “You” or “you” means you and the Member.

1. License Grant - Use of LXI Software. During the term of this Agreement, LXI hereby grants you the non-exclusive, non-transferable, paid-up, royalty-free, free of charge, revocable, limited right and license to download, copy, modify, install, and execute the LXI Software for use solely in connection with the development, manufacture and sale of LXI Conformant Products. “LXI Conformant Products” shall mean those products for which you have successfully completed all requirements (the “Certification Requirements”) set forth in the document entitled “LXI Consortium Policy for Certifying Conformance to LXI Consortium Standards,” which document is available on www.lxistandard.org (the “LXI Website”). For the avoidance of doubt, your use of the LXI Software does not guarantee that your product will be an LXI Conformant Product, and you have the sole and ultimate responsibility to ensure that your product complies with the Certification Requirements.

2. Obligations. Unless otherwise specifically agreed by LXI in writing, you: (a) shall not distribute, sublicense, transfer, loan or otherwise provide the LXI Software to any third party outside your own Member organization, except to any third party contracted by you to assist with the development of products (a “Third Party Contractor”), subject to the additional requirements below; (b) shall not reverse compile, reverse engineer or disassemble the executables included with the LXI Software; (c) shall, upon any termination of this Agreement in accordance with the section entitled “Term” below, promptly de-install and discontinue use of the LXI Software, and use commercially reasonable efforts to destroy all copies, including all compressed files, source files or other files (including documentation) made available to you by LXI under this Agreement (and any copies thereof); and (d) shall display, and shall not alter or remove, LXI’s copyright and other proprietary notices.

You shall only provide the LXI Software to a Third Party Contractor pursuant to a written agreement between you and such Third Party Contractor (the “Contractor Agreement”) that provides that the Third Party Contractor: (i) may only use the LXI Software to assist you in

the development of LXI Conformant Products, and shall not distribute, sublicense, transfer, loan or otherwise provide the LXI Software to any other party, (ii) shall protect the confidentiality of the LXI Software, with terms at least as restrictive as the confidentiality requirements set forth herein, (iii) shall not reverse compile, reverse engineer or disassemble the executables included with the LXI Software; (iv) shall, upon the earlier of the termination of this Agreement or the Contractor Agreement, promptly de-install and discontinue use of the LXI Software, and use commercially reasonable efforts to destroy all copies, including all compressed files, source files or other files (including documentation) made available to it (and any copies thereof); (v) shall display, and shall not alter or remove, LXI's copyright and other proprietary notices; and (vi) shall comply with all other restrictions and obligations related to the LXI Software as are set forth in this Agreement, which shall be attached as an exhibit to the Contractor Agreement. You shall ensure compliance by each Third Party Contractor with the foregoing requirements, and you shall indemnify, defend and hold harmless LXI for any failure of any such Third Party Contractor to so comply.

3. Ownership. Subject to the following section related to open source, you acknowledge and agree that the LXI Software is owned and copyrighted by LXI or its third party suppliers. Your license confers no title or ownership in the LXI Software and is not a sale of any rights in the LXI Software. All ownership rights remain in LXI or its third party suppliers, as the case may be.

4. Open Source. You acknowledge and agree that the LXI Software includes certain open source materials (the "Open Source Materials"), including without limitation those Open Source Materials listed in the file entitled "Approved Open Source Software in Deliverables" included with the LXI Software and posted on the LXI Website. Your use of the Open Source Materials is licensed by third parties and is subject to the terms of the applicable licenses as listed in such file. The list of Open Source Materials may be updated by LXI from time to time and it is your obligation to periodically check for any changes to such list. You hereby agree to comply with all terms of such licenses in connection with your use of the LXI Software.

5. No License Change Event. You may not combine the LXI Software (including all source code but excluding the Open Source Materials, the "LXI Proprietary Materials") or any modifications thereto with programs licensed under Open Source License Terms (as defined below) in any manner that could cause, or could be interpreted or asserted to cause, the LXI Proprietary Materials or any modifications to become subject to Open Source License Terms. No license is granted to you hereunder to use, modify, adapt, reproduce, distribute, perform, disclose, modify, make derivative works based upon, or in any way exercise any right with respect to the LXI Proprietary Materials that would result in a License Change Event (as defined below). You will ensure that your engineering, development and distribution efforts authorized hereunder including but not limited to your distribution of LXI Conformant Products do not result in the occurrence of a License Change Event.

"License Change Event" means any occurrence, condition or event that may cause or result in any portion of the LXI Proprietary Materials becoming subject to the terms and conditions of any Open Source License Terms.

“Open Source License Terms” means license terms for software that (i) cause or allow the source code of such software to be available for use, modification and distribution without customary commercial restrictions, (ii) require or allow such software to be distributed without the collection of a fee or with the collection of only such minimal fee as is necessary to cover the costs of distribution of such software; (iii) require the user to make the user’s modifications to the open source code or any software that the user ‘combines’ with the open source code freely available in source code form or (iv) are otherwise substantially similar to, without limitation, software licensed or distributed under the General Public License (GPL) or Lesser/Library GPL (LGPL).

6. Confidentiality. You agree with LXI that the LXI Proprietary Materials constitute confidential information of LXI, and that, unless otherwise specifically authorized by LXI in member company writing, you shall not disclose the LXI Proprietary Materials or the related documentation or any information concerning the LXI Proprietary Materials to any person other than employees or contractors of the Member whose use of the LXI Software is necessary for your development of LXI Conformant Products; provided that such employees and contractors have entered into confidentiality agreements with such Member with terms at least as protective as the confidentiality terms set forth herein. Your obligation of confidentiality shall not extend to information which (i) is publicly known at the time of its disclosure, (ii) is lawfully received from a third party not bound in a confidential relationship to LXI, (iii) is published or otherwise made known to the public by LXI, (iv) was generated independently by you before your receipt from LXI, or (v) is required to be disclosed under any law, governmental rule or regulation or court order. This confidentiality paragraph shall survive the expiration or termination of this Agreement for a period of three (3) years.

7. Feedback. In the event you discover any defect, bug or other problem with the LXI Software (collectively, “Defects”), you may notify LXI of such Defect, in which case LXI would appreciate your provision of reasonable detail in writing and assistance related to the Defect to enable LXI to understand and evaluate the Defect. In addition to the foregoing optional reporting of Defects, you may also provide LXI with other evaluations of or feedback to the LXI Software for purposes of assisting LXI in making improvements to the LXI Software (collectively, with reports of Defects, “Feedback”). If You provide LXI with Feedback, You hereby grant to LXI a perpetual, nonexclusive, world-wide, paid-up, royalty-free and transferable license, including the right of sub-license, to use, commercialize and disclose such Feedback in any manner, including, but not limited to the right to make, have made, use, sell, offer for sale, import, copy, make derivative works, and publicly distribute, perform and display any such Feedback, including incorporating such Feedback into the LXI Software. You shall not provide any evaluations, Feedback or other information to LXI unless such information complies with the terms of LXI’s Antitrust Compliance Guidelines (the “Antitrust Guidelines”). A copy of the Antitrust Guidelines is included in the file entitled “Antitrust Guidelines” included with the LXI Software and is posted on the LXI Website. By clicking on the “Accept” button, you hereby confirm that you have reviewed the Antitrust Guidelines and will comply therewith in connection with your use of the LXI Software.

8. Support. The current support and maintenance obligations of LXI and its suppliers (“LXI Support”) are set forth in the document entitled “LXI Reference Design Support Information” on the LXI Website. Although LXI intends to provide LXI Support to the extent practicable from an organizational, financial and technological standpoint, LXI does not represent or warrant that LXI Support will be provided for the term of this Agreement. For the avoidance of doubt, the LXI Support may be amended, suspended or terminated by LXI in its sole discretion. The LXI Reference Design Support Information document shall be available for your review on the LXI Website to determine the current status of LXI Support.

9. NO WARRANTY AND NO LIABILITY. LXI and its suppliers make no warranties whatsoever as to the operational performance of the LXI Software. LXI will not provide any support or bug fixes for the LXI Software, except to the extent LXI expressly elects to provide LXI Support. **TO THE MAXIMUM EXTENT PERMITTED BY LAW, LXI AND ITS SUPPLIERS DISCLAIM ALL WARRANTIES, EXPRESS OR IMPLIED. IN PARTICULAR, THE LXI SOFTWARE IS PROVIDED “AS IS”, WITHOUT WARRANTY OF ANY KIND, INCLUDING WITHOUT LIMITATION THE WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. LXI PROVIDES NO WARRANTY WHATSOEVER WITH RESPECT TO THE OPEN SOURCE MATERIALS.** The entire risk as to the quality and performance of the LXI Software is borne by you. Should the LXI Software prove defective, you and not LXI assume the entire cost of any service and repair in connection with your use, except to the extent LXI expressly elects to provide LXI Support. This disclaimer of warranty constitutes an essential part of this Agreement. **SOME JURISDICTIONS DO NOT ALLOW EXCLUSIONS OF AN IMPLIED WARRANTY, SO THIS DISCLAIMER MAY NOT APPLY TO YOU AND YOU MAY HAVE OTHER LEGAL RIGHTS THAT VARY BY JURISDICTION.**

Because LXI Software is inherently complex and may not be completely free of errors, you are advised to verify and back up your work. Additionally, LXI does not guarantee compatibility between the LXI Software and any production or other future versions of the LXI Software.

10. LIMITATIONS ON LIABILITY. TO THE MAXIMUM EXTENT PERMITTED BY LAW, UNDER NO CIRCUMSTANCES AND UNDER NO LEGAL THEORY, TORT, CONTRACT, OR OTHERWISE, SHALL LXI BE LIABLE TO YOU OR ANY OTHER PERSON FOR ANY MONEY DAMAGES, WHETHER DIRECT, INDIRECT, SPECIAL, INCIDENTAL, COVER, RELIANCE OR CONSEQUENTIAL DAMAGES, EVEN IF LXI HAS BEEN INFORMED OF THE POSSIBILITY OF SUCH DAMAGES, OR FOR ANY CLAIM BY ANY OTHER PARTY. IN THE EVENT THAT NOTWITHSTANDING THE FOREGOING, LXI IS FOUND LIABLE TO YOU FOR DAMAGES FROM ANY CAUSE WHATSOEVER, AND REGARDLESS OF THE FORM OF THE ACTION (WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE), PRODUCT LIABILITY OR OTHERWISE), LXI’S LIABILITY TO YOU WILL BE LIMITED TO THE GREATER OF \$25 OR THE AMOUNT YOU PAID FOR THE LXI SOFTWARE. SOME JURISDICTIONS DO NOT ALLOW THE

EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THIS LIMITATION AND EXCLUSION MAY NOT APPLY TO YOU.

11. Export Controls. The LXI Software is subject to the U.S. Export Administration Regulations and other U.S. law and may not be exported or re-exported to certain countries or to persons or entities prohibited from receiving U.S. exports (including Denied Parties, Specially Designated Nationals, and entities on the Bureau of Export Administration Entity List or involved with missile technology or nuclear, chemical or biological weapons). The LXI Software also may be subject to the export, import or other laws of other countries. LXI makes no representation that any LXI Software to be distributed hereunder is appropriate or available for use in countries outside the United States. You agree not to use or transfer the LXI Software in violation of any U.S. or foreign laws or regulations.

12. U.S. Government End Users. The LXI Software is a “commercial item,” as that term is defined in 48 C.F.R. 12.101 (Oct. 1995), consisting of “commercial computer software” and “commercial computer software documentation,” as such terms are used in 48 C.F.R. 12.212 (Sept. 1995). Consistent with 48 C.F.R. 12.212 and 48 C.F.R. 227.7202-1 through 227.7202-4 (June 1995), all U.S. Government End Users acquire the LXI Software with only those rights set forth herein

13. Term. This Agreement shall remain in full force and effect until the earlier of (i) termination by you in writing or (ii) automatic termination in accordance with this paragraph. In the event the Member’s membership in LXI expires or terminates for any reason, this Agreement shall automatically terminate upon such membership termination. Upon any termination or expiration of this Agreement, you must discontinue all use of the LXI Software and shall use commercially reasonable efforts to immediately destroy the LXI Software together with all copies, and cause all third party contractors to which the LXI Software has been provided by you to do the same; provided that the foregoing termination does not impact your ability to continue to manufacture and sell LXI Conformant Products for which you have completed the Certification Requirements prior to the date of termination, unless otherwise specified in any agreement between you and LXI. The provisions of this Agreement (other than your license to use the LXI Software set forth in Section 1) shall survive the termination or expiration of this Agreement.

14. Controlling Law and Severability. This Agreement constitutes the entire agreement between you and LXI with reference to this transaction. This Agreement will be governed by the laws of the State of Colorado, USA, except for that body of law dealing with conflicts of law. The application to this Agreement of the United Nations Convention on Contracts for the International Sale of Goods is hereby expressly excluded. In the event of any dispute involving this Agreement, LXI and you each consent to exclusive jurisdiction and venue in either the state or federal courts in the State of Colorado. In the event any provision of this Agreement shall be deemed unenforceable, void or invalid, such provision shall be modified so as to make it valid and enforceable, and as so modified the entire Agreement shall remain in full force and effect. No decision, action or inaction by LXI shall be construed to be a waiver of any rights or remedies available to it.
